The City of Anderson Community Development Department will submit to the U.S. Department of Housing and Urban Development (HUD) a Consolidated Plan Annual Performance Evaluation Report (CAPER) for Program Year (PY) 2021-2022. PY 2021-2022 was the second program year of the 2020-2024 Consolidated Plan. Title 1 of the National Affordable Housing Act established the requirement that municipalities receiving funds under specific Housing and Urban Development (HUD) programs such as Community Development Block Grant (CDBG) and HOME Investment Partnership Program (HOME) have an approved housing and community development strategy. The primary purpose of the CAPER is to report progress made in carrying out the Five-year Consolidated Plan and Second-year Action Plan. The document also allows the municipality to assess its annual performance in relation to meeting the overall Five-Year Consolidated plan priorities and objectives and determining actions or changes the City intends to make as a result of the annual performance. The City of Anderson must make the CAPER available to the general public for examination and comment for 15 days. Therefore, the Community Development Department is making available to the general public the draft document.
